NEW INTAKE ADMISSION APPLICATIONS FOR SEPTEMBER 2024

If you do not receive an offer of a place at your highest preference school, you can appeal against the decision.

- For applications made in the normal admissions round, appeals must be heard within 40 school days of the deadline for lodging appeals.
- For late applications, appeals should be heard within 40 school days from the deadline for lodging appeals where possible, or within 30 school days of the appeal being lodged
- For in-year applications, appeals should be heard within 30 school days of the appeal being lodged.

The relevant appeal dates for 2024 are:

1 March 2024 The national offer day for secondary school places for

September 2024

15 April 2024 The latest date to lodge an appeal against a refusal of a

place if you want it heard before the end of the summer

term

Up to 18 June 2024 Appeals heard by the Local Authority Statutory Appeals Panel

for those submitted by the deadline

Up to 22 July 2024 Appeals heard, where possible, for late appeals (last day of

term: 22 July 2024)

31 August 2024 Waiting list maintained by the Local Authority and thereafter by

the school

September 2024 onwards Any appeals not heard before 22 July 2024

After the appeal hearing you will receive a decision letter within five school days of the hearing wherever possible.





IN-YEAR ADMISSIONS 2024-25

If your application for a place has been refused, you have the right to appeal. For most schools in Essex you can appeal online via the Local Authority's website: https://www.essex.gov.uk/after-your-school-offer/appeals You can also download an appeal form from the Local Authority's website or complete and return the appeal form at Appendix A to the Local Authority Statutory Appeals Team.

You will be given a deadline for lodging the appeal which allows at least 20 school days from the date of notification that your application was unsuccessful to prepare and lodge your appeal. The completed appeal form should be sent to: Statutory Appeals Team, PO Box 11, Chelmsford, Essex, CM1 1LX.

On receipt of the appeal form an appeal hearing must be arranged within 30 school days of the appeal being lodged. You will receive at least 10 school days' notice of the date of the appeal hearing. You will be given a reasonable deadline to submit additional evidence in order that the clerk can send the appeal papers to all parties.

After the appeal hearing you will receive a decision letter within five school days of the hearing wherever possible.
